NSW Government COVID-19 Response

New 8 November roadmap freedoms

From **8 November**, more freedoms will apply to those who are **fully vaccinated** (16 years and older) and those with **medical exemptions** as part of the **Reopening NSW Roadmap**. People under 16 who are not fully vaccinated, will still need to be accompanied in certain settings.

Density limits

- Density limits will change to **1 person per 2 sqm**.



Masks

- The current **mask settings** which apply to everyone, will remain until NSW reaches 95 per cent double vaccination or 15 December, whichever happens first.

NO LIMIT



Visiting family and friends

- **No limit** to the number of visitors in your **home**.
- **No limit** to the number of people for **outdoor public gatherings** and recreation. A COVID Safety Plan is required if more than 1000 people attend.
- All visitors to **aged care facilities** and **disability homes** are permitted in line with their policies.



Restaurants and hospitality

- **No person** or **booking limit** in hospitality venues.
- **Singing and dancing** is permitted indoors and outdoors.
- Drinking indoors and outdoors may be **seated or standing**.



Events and entertainment

- **No person limit** for **major recreation facilities** (including stadiums and theme parks), subject to density limits or 100% of fixed seated capacity.
- **No person limit** for **entertainment facilities** (including cinemas and theatres), subject to density limits or 100% of fixed seated capacity.
- **No person limit** for **information and education facilities** (including art galleries and libraries), density limits still apply.

Proof of COVID-19 vaccination

What you need to know

As we reopen NSW, persons aged 16 and over will only be permitted to enter certain venues or settings if they are fully vaccinated or have a medical exemption. In some venues, children under 16 will have to be accompanied by a fully vaccinated member of their household to enter.

There are several options to show proof of COVID-19 vaccination. More detail can be found at nsw.gov.au

Which settings will require proof of full COVID-19 vaccination?

Anyone aged 16 or over will need to be fully vaccinated (or have an exemption) to enter most venues including hospitality venues, non-critical retail stores, personal services, sporting, recreation and entertainment facilities and events. Critical retail such as supermarkets or pharmacies will still be accessible for people who are not fully vaccinated.

How can customers, staff and visitors show proof of their COVID-19 vaccination status?

Once fully vaccinated (two doses) with an approved COVID-19 vaccine, there are several options to access and share proof of COVID-19 vaccination:

- [COVID-19 digital certificate](#) can be accessed through the Express Plus Medicare mobile app or Medicare online account through myGov. The COVID-19 digital certificate can be added to a smartphone wallet or similar. Visit Services Australia for instructions
- Printed version of the COVID-19 digital certificate or immunisation history statement (available through myGov)
- COVID-19 digital certificate can also be added to a Service NSW app and shared as part of a QR check-in. Visit nsw.gov.au for details.

For people without a Medicare card:

- Call the Australian Immunisation Register on 1800 653 809 and ask for an immunisation history statement to be posted. It can take up to 14 days to arrive
- Add a COVID-19 digital certificate to a smartphone wallet or similar using the Individual Healthcare Identifiers service (IHI service) through myGov
- An immunisation history statement can be accessed from My Health Record. Visit Services Australia for instructions.

For people without a smartphone or online access:

A COVID-19 digital certificate or immunisation history statement can be accessed via myGov to download and print. Alternatively, call the Australian Immunisation Register to request a copy in the post.

For people with a medical exemption:

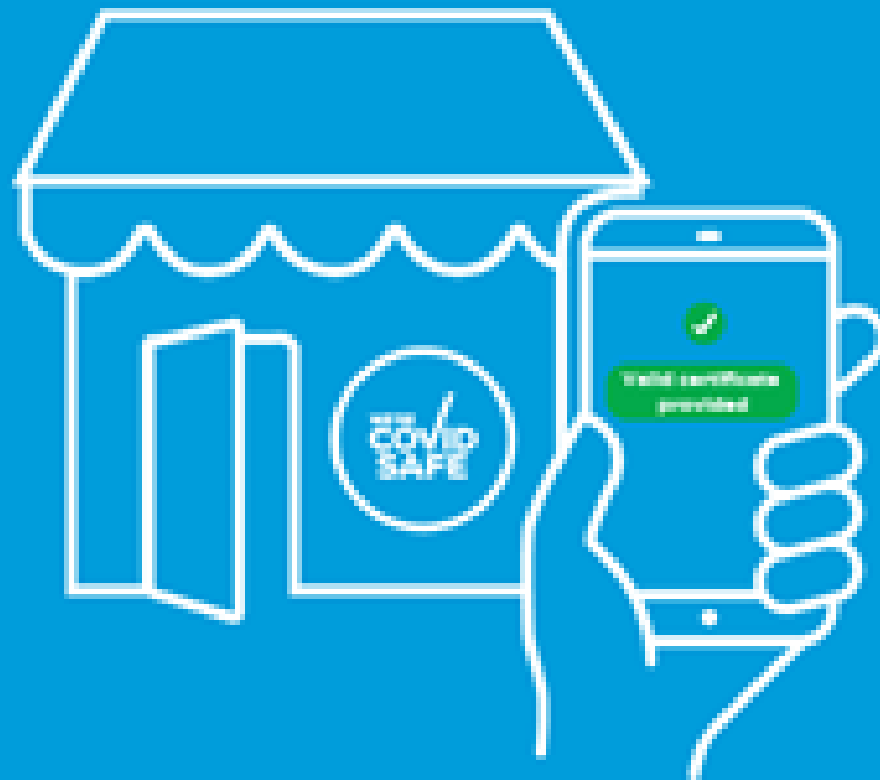
If you have a medical reason for not receiving the COVID-19 vaccination, speak to your medical practitioner about getting your medical contraindication added to your immunisation history.

Penalties may apply for making or presenting a fake form of proof of vaccination.

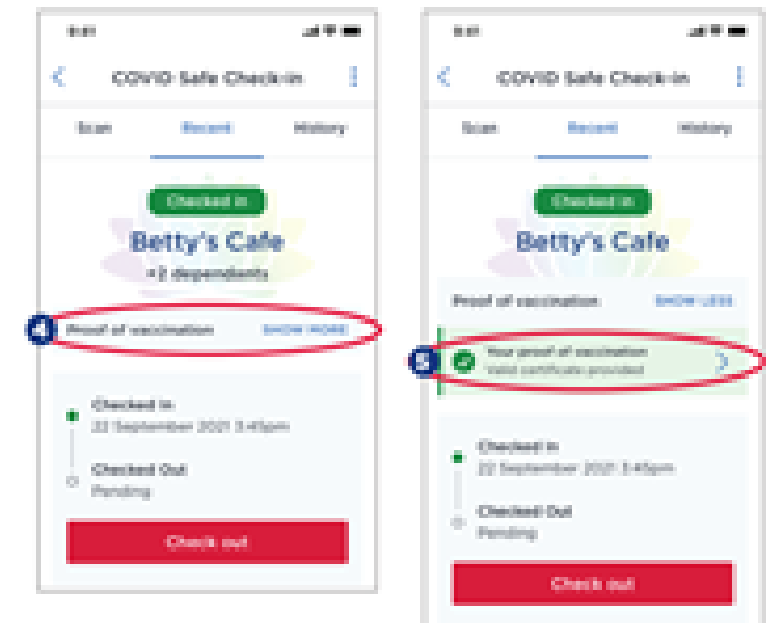
How to check for proof of COVID-19 vaccination using the Service NSW app

Customers and staff now need to show you proof of COVID-19 vaccination and check in to your business as a condition of entry.

If visitors to your business are using the Service NSW app, they need to firstly link their COVID-19 digital certificate to the app. For information on how to do this go to nsw.gov.au

Follow these steps for a quick, easy and secure way to check every visitor, every time they enter your business.

- 1 Visitors can scan your NSW Government QR code using the COVID safe poster at the entrance of your business.
- 2 The Service NSW app will show their name, mobile number and vaccination status.
- 3 Visitors can add dependents if needed and complete the check in to your business.
- 4 Customer can show you the completed check in screen, which includes a new 'Proof of vaccination SHOW MORE' field.
- 5 To check proof of vaccination, you can ask the customer to tap the 'Proof of vaccination SHOW MORE' field. The customer can then tap the green 'Your proof of vaccination' field to show their COVID-19 digital certificate.



You may be fined \$1,000 if you don't comply.
